V. Coding System

Date code stamped on case and bottom of bottles indicate date and year of production (Julian Date). The first digit is the year followed by three digits signifying the day of the year. Example: 9055 = Year of 2019, the 55th day of the year, (February 24, 2019).

VI. Handling and Storage

A. Temperature – Store between 65° - 120° F (18° - 49° C).
B. Shelf Life – In excess of 24 months from date of manufacture.
