IX. Coding System

A five-digit date code stamped on all product containers indicates date of production. The first two digits are the last two numbers of the year followed by the Julian Date. Example: 20204 = Year of 2020, $\#204^{\text{th}}$ day of the year, (July 22, 2020).

X. Handling and Storage

- A. Temperature Store between 65° $120^{\circ}F$ (18° $49^{\circ}C$).
- B. Shelf Life 730 days from date of manufacture.
- C. Shake well before using and point tip to red dot.
