I. Ingredient Statement

Water, Modified Food Starch, Propylene Glycol, Caramel Color, Citric Acid, Potassium Sorbate, Sodium Benzoate, Propylene Glycol Alginate and Propellant.

II. Application Baked Goods Ingredient Labeling
