X. Handling and Storage

- A. Temperature Store between 65° 120° F (18° 49° C) in powder form.

 Refrigerate at <40°F/4°C when reconstituted into liquid form.
- B. Shelf Life 547 days in powder form from date of manufacture when sealed. FIVE days after adding water, if kept refrigerated.
